#### Notes on Payment & Funding Schemes: SkillsFuture Credit, WSS, ETSS, Other Fees, Change of Citizenship & Subsidy

All Singaporeans aged 25 years and above can make use of SkillsFuture Credit to pay for course fees. The One-Off SkillsFuture Credit Top-up of \$500 is available for use from 1 April 2020 to 31 Dec 2025.

#### For courses commencing on or after 1 Jan 2023, \*Small and Medium-sized Enterprise (SME) is defined as

- i. Registered or incorporated in Singapore; AND
- ii. Annual sales turnover<sup>1</sup> of not more than \$100 million OR employment size<sup>2</sup> of not more than 200 employees.
  - <sup>1</sup> Annual sales turnover refers to the revenue or sales turnover stated on the company's income statement.
  - <sup>2</sup> A company should include in its employment size any persons employed under a contract of service in accordance to the Employment Act. This is regardless of the nationality of the employee.

Enhanced Training Support for SMEs (ETSS) subsidy is only applicable to Singaporean and Permanent Residents with full-fee company sponsorship.
